Hello Mr./Mrs Vormawor. I am one of the current home owners here in Milford Highlands and a member of the Board of Directors.

I am writing to let you know that a boat was abandoned on your lot 68 sometime between June 22 - 29.

I suggest you contact the State Police at the Blooming Grove Barracks - 570-226-5718 and report an illegal dumping or as an abandon boat. They may be able to find out who the last owner was using the hull serial number BL3G150KD686. It looks to be about 18 feet in length made by Bayliner in 1986, model "Capri" with a 5.0 liter V8 engine. The trailer information is unreadable. Pictures are attached. There are a few web sites that can provide a report about the boat for a fee which may include owner history.

As per the Protective Covenants the abandon boat cannot be allowed to remain on the property and must be removed in 30 days. See Article V, section 12, "Vehicles, Trailers and Water Craft".

Lastly, it seems you are past due for the first payment of the property owners association dues on lots 67 and 68.
